Lowe's Home Center (Moberly) withdrew their quote after determining they would be unable to supply a product which would meet specifications.

Baldwin Pole Mississippi, LLC submitted a "No Quote" response (They make round utility poles not square posts). The Home Depot of Columbia submitted a "No Quote" response (Due to certification and inspection requirements). P.E. Jepson Lumber submitted a "No Quote" response (Treating plants don't like independent company coming in to re-test product. They have sufficient guidelines in place). Trees Unlimited, Inc. submitted a "No Quote" response (Refuse to accept liquidated damages terms, and inspection and acceptance terms, as well as open warranty).

Notification of the posting of the RFQ opportunity was also sent to Continental Timber Co., Jack's Municipal Sales & Service, J.P. Whelan Co., McIntire Enterprises, Meeks Bldg Centers of Berryville, Jefferson City, Mexico, and Republic, Midwestern Wholesalers, Missouri Poster & Banner, Norman Lumber Co., Pioneer Lumber Co., Quinn Lumber Co., Schutte Lumber Co., Sierra Safety Co., Universal Forest Products, Viking Forest Products, and Wheeler Lumber, but no responses were received from these vendors.
