The Missouri Highways and Transportation Commission is requesting the services of a consulting engineering firm to perform the described professional services for the project included on the attached list.

We will utilize the consultant information already on file so we will not need a lengthy submittal of other general company information.

DBE firms must be certified by the Missouri Department of Transportation in order to be counted as participation towards an established DBE Goal. We encourage DBE firms to submit letters of interest as prime consultants for any projects they feel can be managed by their firm.

MoDOT will evaluate firms based on: Past Performance with Practical Design, Overall Past Performance for MoDOT and others, Qualifications of Personnel Assigned, Familiarity/Capability, General Experience of Firm & Staff, and Accessibility of Firm and Staff.

We request all letters be received by 3:00 pm, August 17, 2012 at the appropriate office.

Proposed Improvement:	The I-64 Daniel Boone Bridge Project will construct a new Missouri River Bridge to connect St. Charles and St. Louis Counties and remove the existing westbound bridge (J10005). It will also provide a bicycle/pedestrian facility to connect the Katy Trail State Park to the Monarch Levee Trail. The improvements include actions to construct a river bridge, rehabilitate or replace deteriorated pavement and bridges; improve traffic operations, geometrics, and safety; and to add mainline capacity.
